- 10. In pursuance of Rules 76 and 77 of its Rules of Procedure, the Commission has granted certain non-governmental organizations observer status.
- 11. The NGOs which have so far been granted observer status are in the list attached to this Report as Annex V.

III. Periodic Reports

12. The Commission considered at its Ninth Ordinary Session the Periodic Reports of the following countries: The Great Socialist Peoples' Libyan Arab Jamahiriya, Tunisia and Rwanda. These documents are public documents and are available at the Secretariat of the Commission.

IV. Consideration of Communications

Protective Activities

13. At its Eighth and Ninth Sessions, the Commission considered 16 communications directed against States Parties to the Charter of which 6 were new.
