INFORMATION FOR PARTICIPANTS

1. General

The 79th Ordinary Session of the African Commission on Human and Peoples' Rights (the Commission) will be held as a hybrid session in Banjul, Republic of The Gambia from *14 May to 3 June 2024*. Only members of the Commission and staff of its Secretariat will physically attend the Session in Banjul, The Gambia, while all other participants will attend the Session online using the Zoom link to be provided.

The Public Session will take place virtually from 14 May to 24 May 2024; the Private Sessions will take place from 25 to 2 June 2024 and; the Closing Ceremony, which will be a public event, will also be held virtually on 3 June 2024.
